

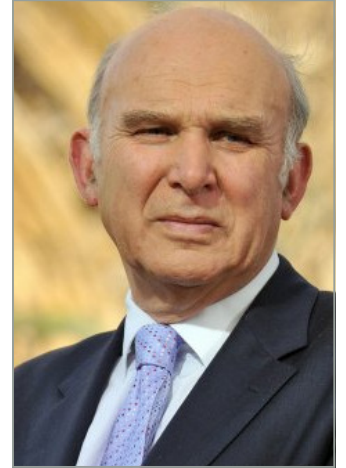


VIP Dinner Discussion Three/18 with The Rt Hon Sir Vince Cable MP Leader of the Liberal Democrats
